Review of meeting minutes

The minutes of the March 1, 2018 meeting were reviewed and accepted as presented.

Web Based Resource Guide

Deb Schrader updated the group on the website. Google analytics were shared with the group.

Evidenced Based Prevention

Capturing Kids Hearts

Liz Timmerman updated the group on Capturing Kids Hearts. Training elementary staff in May 29 and 30th has been scheduled. Lenox Schools will not be participating next year.

Circle of Security

Two staff from Crossroads will be attending Circle of Security training in June 25th - 28th in Spokane Washington.

Other Trainings

Mental Health First Aid Training (Adult and Youth)

A youth training is scheduled April 9, 2018 from 8:00 -5:00 at AJ Counseling in Corning.

Adult mental health trainings will be held at SWCC once a month on the 3rd Thursday from 8:00-5:00 starting in May - November. To date 100 community partners have been trained and close to 75% live or work in Adams or Taylor County.

Nurtured Heart Approach

Liz updated the group on the 5 group parent education Nurtured Heart Approach classes that Stacey Lancaster held. There were 15 parents and all but one parent finished the class. Liz will get the evaluation data to Deb. Sarah announced she will be changing her role at AEA next and will be doing Early Access and going part time which will allow her more time to focus on Nurtured Heart Approach. Liz will sign up to attend the June 24the - 29th NHA training in Minnesota.

System Solutions

Other Items

FY19 Meeting Dates

A schedule of FY19 coalition meeting dates were discussed. The Coalition will continue to meet the 1st Thursday of the month at 11:45-1:00 with the exception of July due to the holiday.

2nd Annual Summit

The 2nd annual behavioral health summit will be May 23, 2018 from 9:30-3:00 and each Coalition is allowed to bring up to 7 community partners. Liz, Sarah, and Deb will attend and Kris Richey may also attend. Anyone attending will be reimbursed for mileage. The Coalition discussed what program should be highlighted and it was consensus to have t the Nurtured Heart approach present.

Budget

The Coalition reviewed the FY18 budget. The following was noted.

- Capturing Kids Hearts There will be \$1,000 left in the Capturing Kids Hearts and that additional curriculum will be purchased with the funds.
- Nurtured Heart Approach There may be approximately \$1,366 left in the parent education line and there is \$1,456 left in the train the trainer line for a total of \$2,822 to utilize to send Liz to training. Deb requested \$1,500 more funding to cover the expenses.
- Mental Health First Aid training Currently there is \$122 left in the line item. Deb has requested \$1,150 more funding to purchase mental health first aid books.
- Circle of Security There is \$12,000 allotted for this expense and more will be known about the expenses in June.
- It is anticipated that all \$88,169 grant funds will be expended by June 30, 2018.

Child Abuse Prevention Grant

Funding was written into the child abuse prevention grant from DHS to support Circle of Security for FY19 and FY20. It was reported the grant did not meet the submittal deadline and that a letter of reconsideration was requested.

Next Steps

- •Deb will start to work on the FY19 budget. This will be a major topic of discussion at the May meeting.
- •Deb will get a Memorandum of Understanding to Liz Timmerman for the Nurtured Heart Approach train the trainer once she receives word that additional funding has been received and all expenses for the NHA training have bee recorded.

Hidden in Plain Sight

The Coalition participated in the display by Brandy Powers that was set up in a room adjacent to the meeting room. Participants were able to view items that appear to be normal but were really ways to hide alcohol, tobacco or other drugs.
