## **Parents as Teachers**

To date 63 personal home visits were provided for Adams County families and 148 personal visits were provided for Taylor County families.

**Budget Update**

Deb provided an update on the budget, 98% has been expended and all but \$9.33 will be expended by the end of the year. There was an additional \$6,195.48 allocated to Parents as Teachers on 5-31-19. The budget has increased by \$31,995 since July 1, 2018. Over the three year period the budget increased by 53%.

**Celebration**

A celebration to end the 3 year grant will be June 24, 2019 from 6:00-8:00 at the Winery in Corning. There will be testimonials from those that have benefited from the services. Everyone is invited to attend. Hy-Vee will provide the catering.

**Mission and Ministry Grant**

Notification of the three year grant that was submitted should be around the 3rd week of June with implementation of July 1, 2019. Once notification has been received of the grant award, Deb will have a conference call with agencies that will be providing the services.

**Community Health Needs Assessment**

Lori Nosekable from Southern Hills Mental Health Region provided presentation regarding the core services provided as well as the new children's mental health system that was approved during the legislative session. Lori explained there was no funding provided for the children's system and there was no change in the amount of county tax levy that regions have to support the children's system.
