Taylor County ISU Extension	Parents as Teachers	To date 77 home visits have been conducted and 21 families served. A group connection/Kids Jubilee will be offered March 2, 2010 at the Lenox School during conferences. They are expecting 250 participants. National Honor Society students will be assisting with the event.
Southwestern Community College	Parents as Teachers	To date 37 visits have been conducted and 7 families served. SWCC in collaboration with the Kid Care Council, will offer a Kids Jubilee event in April, 2020. The PAT program will be going through the Iowa Family Support Credential March 9, 2020 and the program will also be renewed as a PAT Blue Ribbon affiliate, these are both a measure of quality.
DD Consulting & LT Consulting	Nurtured Heart Approach	No report.
Joyce Westphal	Infant & Early Childhood Mental Health Consultation	Consultation session have been provided to home visitors in the Parents as Teachers program. A six hour training focused on trauma and behaviors is scheduled for February 26, 2020 for family support staff. Joyce meets with IDPH, P.J. West monthly for technical assistance. Joyce is also providing leadership with a state wide group with other therapists in supporting consultation.
Crisis Intervention &	Sexual Abuse	Planning continues to be underway and direct service with Second Step Child

Advocacy	Prevention	Protection Unit will begin the 2nd half of the school year with Southwest Valley and Lenox Schools. CIAC has reached out to Bedford Schools as to their interest in programming but have not had any luck so far.
Southwest Valley Schools	OWLS	No report.
Coalition Members	Outreach Efforts	Jessica Paulsen and Debra Simmonds reported they have contacted P.J. West from IDPH to provide an ACEs training with the possibilities of integrating Pediatrician Tabitha Wilson into the training. The training would be marketed to health care providers as well as parents. Debra will secure a date for next spring and will work with CHI, Marilia Mullen on marketing and outreach. The training needs to be completed by May 31, 2020.

FY20 Budget

The Coalition was provided with a budget update, to date 29% of the funds have been expended. It is anticipated that 42% of funds will be expended by the end of December.

Presentation

Tasha Jones from Connections Area Agency on Ageing provided a presentation about the services offered and needs for seniors. Tasha reported that 1 in 14 seniors are victims of abuse but 1 in 24 are actually reported. The Coalition is gathering data as to the needs of the senior population for the Violence Prevention grant. Addressing education about elder abuse and support for grandparents raising children were discussed.

Prevent Child Abuse Prevention Grant

The child abuse prevention grant was announced on November 20, 2019. Adams County Kid Care Council to serve Adams County will be applying for up to \$70,000. Programming can consist of parent development, home visitation and/or sexual abuse prevention. Grant applications are due January 13, 2020.

Violence Prevention Grant Planning

Deb Schrader shared the current letter of intent requirements as well as a sample work plan.

There will be no January meeting due to the holiday.

The next meeting is February 6, 2020 and will be at CHI Health Mercy Corning hospital.
