Budget Updates

The 2nd year of the grant was successful in spending down 100% of the funds which was \$168,892. The 3rd and final year budget is \$168,260.

FY21 Annual Report

The FY21 executive summary and annual report was reviewed and will be used as a marketing piece for the Coalition as well as the hospital. The majority of the programs met or exceeded grant expectations. A report will also be sent to the funder.

Violence Prevention Grant

On July 14, 2021 Mission and Ministry fund provided notification of a \$70,000 violence prevention planning grant which was far less than the three year implementation grant applied for in the amount of \$804,000. A meeting with CHI staff and the Mission and Ministry fund took place July 30th to determine programming and next steps. This grant is considered a planning grant for one year with the encouragement to apply for a three year implementation grant in FY23. After careful review of the Mission and Ministry program model for violence prevention, two of the original eight programs, Coaching Boys to Men to be provided by Crisis Intervention & Advocacy Center and Mental Health Training and Consultation to be provided by Joyce Westphal were selected. These fit the MMF model the best, are evidenced based and produce results quickly. The Coalition had rich discussion regarding as to what program components would make a successful grant application and human trafficking was discussed. Additionally, the Coalition will do some planning around needs and assets in order to be prepared for the next grant cycle. CHI Community Betterment has also committed \$16,000 for FY22 and \$10,665 of Crisis Intervention & Advocacy Center has commented \$10,665.

Community Health Needs Assessment

CHI Health Mercy Corning will conduct and community health needs assessment and the Behavioral Health Coalition has been invited to provide input. The October 7, 2021 meeting will be dedicated to this task.

Next Meeting

Meeting adjourned at 1:10 P.M. There is no July meeting. The next meeting is September 2, 2021 and it will be in person.
