## **Budget Updates**

*Resiliency Grant* – This is the 3<sup>rd</sup> and final year of the grant, to date 26.1% of \$168,260 in funding has been expended. *Violence Prevention Grant and Healthy Communities Grant* – This is the first year of the grant, to date 20.7% of \$86,000 has been expended.

### **Other Information**

- CHI Health Mercy Corning conducted a community health needs assessment on October 7, 2021 and will share the completed assessment in April or May 2021.
- Early Childhood Iowa is conducting a needs assessment in Iowa and parents are requested to provide input utilizing an online survey.
- The Iowa Department of Public Health and the Iowa Department of Human Services are working to align the departments and a change package is available to the public. The goal is to become one Department, Health and Human Services.
- The congressional, senate and house districts change due to the latest population changes.
- A collective impact survey will be sent to Coalition members to assist with quality efforts.
- Zion is working on several initiatives; the strategic logic model will be due at the end of December; substance abuse 101 presentations are available to the public and nursing credit is available.
- Monday June 27, 2022 from 5:00 7:00 has been reserved at the Corning Winery for a celebration of the three year grant.
