Welcome/Introductions

At 11:45 Debra Schrader opened the meeting and introductions were made.

Review of meeting minutes

Jess Petter, Crossroads Behavioral Health Services provided a presentation about OWI classes offered in the area.

Collaboration and Meeting Structure

In February, the Sarah Gulliatt, Taylor County Public Health, representing the Taylor County Interagency approached the Behavioral Health Coalition about collaborating together on meetings since a high majority of attendees are the same at each of the meetings. The Coalition had discussion as to the pros and cons of meeting as one group. The agenda will be modified to allow time for agency updates and to accommodate both parties. The meetings will continue to be at 11:45 – 1:00 and will meet the 1st Thursday of the month with the exceptions of January and July and a hybrid meeting participation option will continue to be offered. Budget Update

CHI Health Mission and Ministry Violence Prevention 1 Year Implementation Grant and Healthy Communities Grant – The total award from MMF is \$168,250 with a cash match from CHI Healthy Communities of \$16,000. To date 49.8% has been expended. All contractors indicate they will spend 100% of the grant funding by June 30, 2023.

Other Information

- Common Good Iowa data snapshots for Adams and Taylor County were reviewed.
- Several legislative bills were reviewed.
- Kristie Nixon shared that Parent Cafes will be offered April 3, April 17, May1 and May 15 at the SWCC performing Arts Center from 5:30-7:30, meal and child care will be provided.
- CHI and other community partners are collaborating on a community calendar that will provide a one stop shop as to activities for youth in Adams County. A community calendar will be available at the Main Street Corning website.
- Lisa Carstens, ZION Integrated Behavioral Health Services, SUD & Problem Gambling Prevention. Lisa updated the group on efforts being made by prevention staff to distribute posters to businesses in Adams County to promote the Savor the Moment media campaign for the alcohol strategy. March is Problem Gambling Awareness Month. Lisa gave a short presentation on sports betting, including information from the 2023 Super Bowl. The American Gaming Association projected a record 50.4 million Americans would wager \$16 billion on this year's Super Bowl...double last year's estimate. That includes not only bets placed with legal sportsbooks, which AGA estimates a about \$1 billion but also wagers with unregulated offshore sites, and social bets among friends or co-workers. She also shared that she had not seen official numbers of actual dollars bet total for the 2023 Super Bowl, but FanDuel said it was taking 50,000 bets per minute at its peak; and DraftKings paid out \$2.68 million to a single bettor on the Chief's win. In Las Vegas, BigMGM said this was the most successful Super Bowl and most bet on single game sporting event ever. Currently, sports betting is legalized in 33 states and Washington, DC. The was the first Super Bowl played in a state with legal sports betting. Next year, the Super Bowl will be in Las Vegas...oh boy!
