# **Agency Updates**

Lisa Carstens, Certified Prevention Specialist from ZION Integrated Behavioral Health Services March is Problem Gambling Awareness Month. An estimated 2 million US adults (1%) meet the criteria for severe gambling /problems in a given year. Another 4-6 million (2-3%) meet one or more of the criteria for gambling disorder and are experiencing problems due to their gambling behavior. ### FY24 Mission and Ministry Violence Prevention Grant Update

Deb shared the semi-annual report with the group. The semi-annual report has been sent to Mission and Ministry. Beth Roghar reported that prevention services will begin second semester in Lenox Schools

The FY24 CHI Health Mission and Ministry Violence Prevention grant is \$53,300 and Healthy Communities funding is \$16,000 of which 43.2% of grant funds have been expended.

# **Adams and Taylor County Snapshots**

The Iowa Department of Health and Human Services has drafted snapshots for all 99 Counties in Iowa. The snapshots include data on access to care, mental health, addictive disorders, economic stability and income, housing and transportation, active living and health eating and cancer.

### **Gun Bill**

The Iowa House has passed FH2586 allowing school personnel to carry weapons and to provide funding for resource officers. The Iowa Senate has not debated the bill yet.

# **Insight from Law Enforcement**

Law enforcement provided insight on the challenges they are seeing in families and youth. Screen addictions (video games, phones, tablets etc), respect for authority and youth with mental youth issues are profound. After much discussion, youth in 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> grade should be a target population and mentoring for youth as well as parents should be considered if violence prevention grant would be applied for in the future.
